CONFERMENT OF CHARTERED RISK MANAGER (CRM) AND FELLOW CHARTERED RISK MANAGER (FCRM)

The Chartered Risk Management Institute of Nigeria (CRMI) was established by Act No. 39, 2022 to promote sound Risk Management practices aligned with global standards across both private and public sectors in Nigeria and beyond. It is the only Chartered Risk Management Institute in Nigeria. Originally known as Risk Management Association of Nigeria (RIMAN), the Institute comprises institutional and individual memberships across all sectors.

In furtherance of its capacity-building initiative, the Institute is set to confer the titles of Chartered Risk Manager (CRM) and Fellow Chartered Risk Manager (FCRM) on qualifying individuals with sufficient knowledge and experience in Risk Management. This is a unique, one-time opportunity.

Consequently, we invite applications from qualified individuals for the conferment of Professional Certification - Chartered Risk Manager (CRM) and Fellow Chartered Risk Manager (FCRM).

Below are the application guidelines:

1. Minimum Requirements for the Conferment of CRM. This includes:

- 1.1. Individuals currently in Positions not below:
 - a. **Assistant Director** (Public Sector) or;
 - b. **Assistant General Manager** (Private Sector) or;
 - c. The equivalent of (a) or (b) above in other related sectors or;
 - d. **Ph.D.** Risk Management (Academia) or;
 - e. Financial Risk Manager awarded by the Global Association of Risk Practitioners (FRM) and;
- 1.2. Possess a minimum of **ten (10) years** of experience in a Professional Risk Management role

2. Conferment/ Participation Fees for CRM

- 2.1. Membership Registration and Payment of Annual Dues
- 2.2. **N500,000** (Five Hundred Thousand Naira)

3. Minimum Requirements for the Conferment of FCRM. This includes:

- 3.1. Individuals who have been **CRMI's** Chartered Risk Managers (**CRM**) for at least three (3) years or:
- 3.2. Individuals who have qualified as Chartered Risk Managers (**CRM**), not below **AGM** or equivalent and are not below Chief Risk Officers in Organisations to be determined by the Council and
- 3.3. Possess a minimum of **ten (10) years** of experience in Professional Risk Management.

4. Conferment / Participation Fees for FCRM:

- 4.1. Payment of CRMI Annual Dues
- 4.2. **N400,000** (Four Hundred Thousand Naira Only)

5. Registration

Candidates should obtain Application Forms from the **CRMI** Secretariat or download them from the website: **<https://www.crming.org>**. The completed forms should be submitted to the Secretariat within two weeks.

Before this exercise, **CRMI** conducts a **three-stage Professional Qualifying Examination** for the award of the Chartered Risk Manager (**CRM**). The process of qualifying for professional examinations subsists for those who do not meet the above qualifications.
